## JOB DESCRIPTION

The University of A Coruña's ECRIM research group ([www.ecrim.es](http://www.ecrim.es)), chaired by Professor Patricia Faraldo Cabana, is a partner of the research project *Action Grant Mutual Trust and Social Rehabilitation into Practice – RePerS* (Grant Agreement 766441). This project has been awarded a research grant by the Directorate-General of the European Commission within the framework of the call JUST-JCOO-CRIM-AG-2016 (*Action grants to support transnational projects to promote judicial cooperation in criminal matters*). The duration of this research project will be 24 months (from December 1, 2017 to November 30, 2019), and it has been funded with a total amount of 212,399.23€. The research consortium of this project is formed by six partners, i.e. UDC (ECRIM), University of Turin (Italy, leading partner), Association *Amapola - Progetti per la sicurezza delle persone e delle comunità* (Italy), Romanian Centre of European Policies (Romania), Italian Ministry of Justice, and LiderJust Association (Romania). The project is aimed at comparatively analysing the effective implementation in three EU member states (Italy, Romania and Spain) of three mutual recognition-based framework decisions seeking to improve the cooperation among EU member states in criminal matters, i.e. the framework decision on the application of the principle of mutual recognition to judgments in criminal matters imposing custodial sentences or measures involving deprivation of liberty (FD 2008/909/JHA), the framework decision on the application of the principle of mutual recognition to judgments imposing probation measures and alternative sanctions (FD 2008/909/JHA), and the framework decision on the application of the principle of mutual recognition to decisions on supervision measures as an alternative to provisional detention (FD 2009/829/JHA).

The appointed research fellow will carry out, first and foremost, research tasks, by conducting desk and fieldwork research on the effective implementation of the aforementioned framework decisions in Spain. More precisely, the appointed researcher will prepare working papers and academic articles, present papers in international conferences and participate in the project meetings. In addition, he or she will perform management tasks to ensure the involvement of key stakeholders within the project. Furthermore, the appointed research fellow will carry out teaching duties, including preparing and implementing the teaching resources on the three framework decisions that are one of the deliverables of the research project.

### Job duration

The duration of this position will be 16 months and 21 days, until November 22, 2019.
